PORT SERVICES TARIFF

The Port Services Tariff Conditions, paragraph “c” in the 2.2.1. Definitions section of the 2.2. Container Services page has been revised as follows :

2.2. CONTAINER SERVICES

2.2.1. Descriptions

c) Out of Gauge and Non-Standard Size Container

1. Out of Gauge containers or containers heavier than the spreader safe working load (SWL) are charged as Out of Gauge and Non-Standard dimension containers tariff.
2. Full or Empty containers which can not be handled with the normal container spreader due to small damages such as twistlock etc. are considered Non-Standard dimension containers.
3. Full containers which can not be handled with a normal container spreader, with severe damages, of which the center of gravity has shifted or which have severe deformations are considered as Project cargoes.

PORT SERVICES TARIFF

In the Port Services Tariff Conditions; item 1 of the 2.7. Other Services page, 2.7.7. Vehicle Stand-by paragraph has been revised as follows :

2.7. OTHER SERVICES

2.7.7. Vehicle Stand-by

1. If land vehicles arriving at the terminal area for the purpose of loading and unloading cargo do not leave the terminal on the same day even though their work is finished; a fee of 25 USD + VAT per vehicle is charged for each day they remain idle. However, no additional storage fee is charged for the goods in the vehicle.
